






DYNAMIC OF GROSS REGIONAL PRODUCT, billion rubles




STRUCTURE OF GROSS REGIONAL PRODUCT, %




DYNAMIC OF INVESTMENT VOLUMES IN FIXED ASSETS, billion rubles



DYNAMIC OF FOREIGN INVESTMENTS million dollars




LABOR CAPACITY

FORMS OF STATE SUPPORT OF THE INVESTMENT ACTIVITY

- Elaboration and realization of the regional addressed investment program of the Vladimir Region;
- Granting of budget investment of the Vladimir Region;
- Granting of state guarantees of the regional budget;

- Granting of investment tax credits, deferment or consent to payment in installments;

REGULATED DEVELOPMENT ZONES (RDZ) TYPES:

- Production Zone
- Zone of Adoption of Technical Achievements
- Zone of Small Entrepreneurship Development
- Trading and Warehouse Zone
- Recreation Zone
- Transport and Logistics Zone

MODES OF, REGULATED DEVELOPMENT, SOMES FORMATION:

- by development or arrangement of new areas;
- by reconstruction of the already existing areas.

SOURCES OF, F,INANCING:

- private investment
- budget investment

FORMS OF STATE SUPPORT FOR REGULATED DEVELOPMENT ZONES INITIATORS:

The Regulated Development Zones Administration can be granted the following forms of state support:


- Granting budgetary investments for infrastructure development. Allocation of the specified means is carried out on condition of assigning the corresponding part of shares of the created jointstock company to the state property of the Vladimir region;
- Exemption from the property tax regarding the property liable to taxation according to the Taxation Code of the Russian Federation and being on the balance of the RDZ Administration, located on the territory of the RDZ, reconstructed or newly-built or acquired and used for the RDZ functioning according to the Law of the Vladimir region "On Property Tax of the Organizations";
- Granting state regional budget guaranties;
- Granting deferment or consent to regional tax payments according to Part 1 of the Taxation Code of the Russian Federation;
- Granting budgetary credits.

RDZ participants are granted state support of investment activities in the forms adopted by the legislation of the Vladimir region.


ACTIVITY GUARANTIES WITHIN REGULATED DEVELOPMENT ZONES

- For carrying out their industrial and commercial aims the RDZ participants have the right to use the land, buildings and edifices located on the territory of the RDZ under lease (sublease) in the order and on the conditions stipulated by the legislation of the Russian Federation and the Vladimir region.
- The RDZ participants carry out their business activities on the territory of the RDZ according to the legislation of the Russian Federation. All the RDZ participants are granted equal activity conditions.
- Federal authorities of the Vladimir region guaranty stability of the RDZ participants' rights and have no right to aggravate their activity conditions during the functioning term of the given zone.


PROMISING INDUSTRIAL ZONES
